Zenny by Meta AI will send you daily messages via WhatsApp. As you will be communicating with Meta, Meta will have access to your responses to questions Zenny asked you and the content of any messages that you sent Zenny.

Meta's Collection, Use and Sharing of Your Information

The information that Meta collects when you chat with Zenny by Meta AI includes:

- your phone number
- the content of your messages with Zenny, including your responses to questions
- information about your interactions with Zenny, such as the number of days chatted with Zenny, the number of messages exchanged, the number of characters typed in your messages, time spent talking to Zenny and the number of sessions started and completed
- Summarized engagement data with Zenny, including:
 - numerical data about how you've engaged with the bot, such as number of days chatted with the bot, number of messages exchanged, number of characters typed in free-text entry messages, time spent talking to the bot, and number of sessions you started and completed;
 - content you have viewed, such as the self-care modules started and completed;

- your feedback and satisfaction data, such as the scores you may have given at the end of each self-care module and any free-form feedback you may have entered; and
- your free-text responses you have provided in response to questions asked by the bot, in de-identified form and not linked to specific participants.

Meta will share summarized engagement data with the University of Klagenfurt as part of the Well study. Meta may use the information it collects to improve Zenny and for research purposes. The conversations with Zenny will only be seen by the research team developing Zenny, and will only be used to conduct the Well study and to improve Zenny.
